STUDENT GOVERNMENT**CONSTITUTION**

Whereas, we, the students of Virginia Intermont College, desire to assume responsibility, and thus develop the principles of honor and self-reliance, do hereby in accordance with an agreement between faculty and students organize ourselves into an Association.

ARTICLE I

This organization shall be called the Student Government Association of Virginia Intermont College.

ARTICLE II

The object of this organization shall be to represent and to further the best interests of the Student Body, to secure cooperation between different organizations, and to promote responsibility, self-control and loyalty among the students.

ARTICLE III**Membership**

SECTION I. All students shall be members of the Student Government Association.

SECTION II. All students are responsible for knowledge of this constitution and of all Student Government regulations.

ARTICLE IV**Executive Department**

SECTION I. The officers of the Association serving for first semester shall be elected from the incoming Senior class. President, Secretary, and seven House Presidents shall compose the Executive Board. Seven assistant house presidents shall be elected from the incoming Senior class.

These sixteen, together with a representative from the high school department, compose the Executive Council. The old girls only will vote. The present Student Government members who are returning will retain their duties until the new members go into office.

The officers of the Association serving for second semester shall be: President, elected from Senior class; Secretary, elected from Junior class; seven house presidents, elected from Senior class; one representative elected from high school department; seven assistant house presidents elected from the Junior class. The high school representative shall have been a member of the student body for at least one year. See SECTION IV, E.

SECTION II. Duties of officers:

A. The duties of the President shall be:

1. To preside over all meetings of the Executive Council and the Student Government Association.
2. To grant, during the study hours, such permissions as are deemed advisable.
3. To represent in dormitories the authority of the Student Government Association in all matters entrusted to its control and supervision.
4. To report to Executive Council offenses committed by any member of the Student Government Association.

B. The duties of the secretary shall be:

1. To keep a list of all members of the Association.
2. To prepare and read minutes for each meeting of the Executive Council.
3. To file all offenses dealt with by Executive Council, together with decisions made on

such cases, and to give written notices to students of all penalties imposed by the Executive Council.

- C. The duties of the House Presidents shall be:
1. To represent in their dormitories the authority of the Student Government Association in all matters entrusted to its control and supervision.
 2. To grant, during the study hours, such permissions as are deemed advisable.
- D. The duties of the Assistant House Presidents shall be:
1. To act as assistants to house presidents.
- E. Monitors shall be appointed on each hall each month to assist the officers of student government. Monitors shall also be appointed to check attendance at chapel, vespers, and meals.

SECTION III. Executive Council.

- A. The executive power of the Student Government Association shall be vested in an Executive Council which shall consist of the President, Secretary, seven house presidents, and seven assistant house presidents, and an elected representative from the high school department.
- B. The duties of the Executive Council shall be:
1. To act on all matters not provided for by the Constitution, By-Laws and Regulations of the Association.
- C. The Executive Council shall have the power to impose penalties for any violations of the Stu-

dent Government regulations.

- D. The meetings of the Council shall be held weekly. A majority of those present shall decide all questions.

SECTION IV. Elections.

- A. The Student Government elections for all major offices shall be held each semester.
- B. Nominations shall be made by a Committee of four members of the faculty and ten members of the Association.
- C. Nominations shall be posted one day before elections.
- D. Nominations may be made from the school. The nominations shall be signed by at least ten students. Nominations shall be handed to the Dean of Women, and if the nominee is eligible, her name will be posted.
- E. Elections shall be carried by a majority of votes cast. House Presidents and Assistant House Presidents are elected by students in the buildings which they serve.
- F. There shall be no absentee voting or voting by proxy.
- G. In case of vacancies in major offices, these shall be filled by election, the Executive Council acting as nominating committee for these offices. Other nominations may be made by any ten students prior to the time of election.

ARTICLE V

The Student Government Association recognizes the President of the College as final authority on executive and legislative matters.

REGULATIONS AND INFORMATION**I. DORMITORIES.**

Our life in the college is governed by a thoughtful and sympathetic consideration for others. This individual responsibility must be assumed by each student at all times. There must be reasonable quiet in halls and in all college buildings. Every student at Intermont must cooperate with the Council and Administration in insuring the quiet necessary for study and rest. Many of the usual rules have been dispensed with, and dependence is placed upon individual responsibility and the disposition of each true Intermont student to do the right thing.

A. ROOMS.

1. All rooms shall be kept in order. Beds must be made by 8:30 a. m. on week-days and by 10:00 a. m. on Sundays.
2. All electrical attachments must be used in halls where provision is made for them, and in East Hall kitchen.
3. Nails or tacks may not be driven in walls, wood work, or floors. Pictures may not be pasted to walls. For any nail found driven in a student's wall, there will be a charge of 75c; for anything stuck to walls, 50c. No painting of any kind is allowed. The college will not tolerate writing on or defacing walls, desk, floors, etc.

4. Electric lamps in any room shall not total over 180 watts. Lights shall be turned off when occupants leave rooms; if left burning, a fine will be imposed if reported by hall patrolman.
5. Every member of the Association shall cooperate in protecting grounds and buildings, that they may be useful and beautiful for those who will follow. The cost for repairing any damage to college property will be charged to the student causing the damage.
6. To be eligible for residence in Senior Hall a student must make A in citizenship and must pass all her work, with enough quality credits to make graduation at the end of the second year reasonably sure.
7. All edibles must be kept in tin boxes.
8. Girls should not keep expensive jewelry or money in large sums in their rooms. These should be deposited in the Bank of Intermont. Always lock your door. The college is not responsible for articles or money lost from rooms.

B. SIGNS.

There must be an absolute respect for "Study", "Busy", and "Quiet" signs at all times.

C. TYPEWRITERS AND RADIOS.

Typewriters and radios are to be used with consideration for others at all times. Radios are to be tuned low and will be subject to removal if they are annoying. Radios may be used except from 7:00 p. m. to 10:30 p. m. and after 11:00

p. m. Those who persist in using their radios during study hours will be denied the use of their radios until the end of the semester.

D. STUDY PERIOD.

1. Students must be in their respective rooms for study from 7:00 p.m. until 10:30 p.m. Recreation period from 10:30 p.m. until 10:55 p.m. Monday through Friday. For April and May, as long as Daylight Saving Time is in existence, study hour shall be from 7:30 p. m. to 10:30 p. m. with lights out at 11:00 p. m. No light permissions will be given.
2. Local telephone calls are not to be made during study hour, neither are office girls permitted to go for girls who have local calls.

E. LIGHTS.

Students must be in their respective rooms immediately after the ringing of bell at 10:55 p.m. At ringing of bell at 11:00 p.m., lights must be out except Sunday—then lights will be out at 10:30 p.m.

G. CUTS FROM MEALS.

- Attendance at breakfast is optional. Those who wish breakfast must sign the breakfast slip at lunch on the preceding day. No cuts from lunch and dinner. An unexcused absence from lunch or dinner will be given three reprimands. See Section 4 under Dates; also special privileges described under Merit System. Saturday supper and Sunday supper are optional. Girls may sign for each of these meals in advance. For high school seniors only, Monday lunch will be optional, girls indicating whether they will attend as in the above. This privilege is granted without merit credits.
- Reprimands are given for those coming to break-

fast and not signing and also for those who sign and do not come.

H. DINING ROOM.

1. Tables are organized with faculty heads.
2. Table assignments shall be made every four weeks. Students may not visit at other tables in the dining room.

I. GUESTS.

1. All students must arrange in advance with the Dining Room Hostess for any guests whom they expect to entertain in the dining room.
2. The crowded condition of the school makes it inconvenient to have over-night guests. It is not best for guests or parents to ask for over-night entertainment in students' rooms. Students are expected to call their parents' attention to this regulation. There are a number of over-night guest homes near the college.
3. Mothers or sisters of students may spend only the week-end, Saturday and Sunday nights in the dormitory. Students are to report to the Dean of Women the arrival and departure of all guests. Reprimands will be given for failure to comply with this regulation.

J. CHRISTMAS AND EASTER HOLIDAYS.

1. Dormitory and dining room regulations are suspended to a certain extent during Christmas and Easter holidays. Students staying at the college are under all other rules of the Student Government Association. It is not expected that stu-

dents will remain at college for the holidays. Arrangements may be made with the Dean of Women for South American students or others from a great distance to remain.

K. INFIRMARY

1. Infirmary excuses from chapel cannot be given unless girls go to the infirmary before 8:30 a.m.
2. Girls who are in the infirmary on Sunday or are excused from church on Sunday are not expected to go to town on Monday.
3. Girls may not go to town on the day they come out of the infirmary.

L. SUN BATHS

The following are the only places where girls will be allowed to take sun baths: The sun deck in East Hall, sun deck over the green dining room, sun deck on top of Senior Hall, balcony on second floor Administration.

II. ON CAMPUS.

A. CHAPEL AND VESPERS.

1. All students attend chapel on Tuesday, Thursday, and Friday, and when called on Wednesday; also Sunday vespers in the college chapel. Exceptions: All students are allowed 3 cuts a semester from chapel. The doors will be closed 7 minutes after ringing of the bell and no one may enter chapel late. One cut from Sunday vespers is allowed each semester. See Merit Credits for special cuts.
2. Chapel, vesper, and church cuts must be recorded by the student in the cut book before the date to be used.

3. Unused cuts of any kind do not carry over from the first semester to the second. Unused merit credits do not carry over from quarter to quarter.
4. Students who entertain out-of-town dates on Sundays are not excused from Vespers. Even though an evening date is permitted, the student is expected to attend Vespers or take a regular cut. This regulation applies to church also.

B. COMMUNITY CONCERTS.

All students will attend lectures, concerts, and entertainments provided by the Community Concert Service in Bristol, and any similar entertainments brought to the college auditorium.

1. To be excused from any required college entertainment on account of sickness, permissions are secured from the college nurse; for other reasons, from the Dean of Women.

C. DATES.

1. All arrangements for dates are made through the offices of the Dean of Women.
2. Students making passing grades may have mid-week callers. All students may have callers Sunday afternoons.
 - a. Seniors may entertain dates at the college on each Saturday evening and Sunday afternoons.
 - b. Juniors may entertain dates every other Friday evening and every Sunday afternoon.
 - c. High School students may entertain dates one Friday evening in the month and every Sunday afternoon.

(Note: Merit credits may be used for additional dates. See page 30.)

3. Juniors and High School students, chaperoned by a member of the faculty, on calling evening may go with dates to show or to dinner and show. Otherwise, dates with young men are permitted only at the college.
4. Seniors, with young men, in groups of two or more couples, may go unchaperoned to movies or dinner in Bristol (not out of city limits) on mid-week calling nights, returning to the college by 10:15 p. m. Abuse of this privilege forfeits it for the rest of the session. Other dates with young men are permitted only at the college.
5. Students expecting an out-of-town date at any time will report same to the Dean of Women. If a friend comes unexpectedly, the girl called for must see the Dean of Women before she goes to the reception room, and if the young man has someone with him who wants a date, the Dean of Women must be notified before the girl is asked.
6. Calling hours are from 7:30 p.m. until 10:15 p.m. on Friday and Saturday evenings; from 2:00 p.m. until 5:15 on Sunday. Students having an out-of-town date may attend morning service on Sunday with the date. Otherwise, no dating is permitted before 2:00 p.m. on Sunday. Callers will not be permitted on Sunday evening unless the young man lives a long distance away and cannot come more than two or three times during the semester. Callers from near-by towns, who call Sunday afternoon will not be permitted to call Sunday evening.

7. The Main reception rooms and students' lounge are open for dates during the evening calling hours; Main, East Hall, and Senior Hall reception rooms and students' lounge on Sunday afternoons.
8. The responsibility of the date leaving promptly is placed on each girl. If she fails to comply with this request, she will be deprived of the next date requested.

E. SMOKING.

Students may smoke only in their rooms.

F. ALCOHOLIC BEVERAGES.

The use of alcoholic beverages on or off the campus is strictly prohibited. No alcoholic beverages may be kept in the dormitories.

G. CHEATING.

Cheating is considered a very serious offense.

H. NIGHT RIDING.

Unauthorized automobile riding at night with young men is considered a very serious offense.

I. CLASS RALLIES.

No class demonstrations or gatherings may be held in rooms or corridors of the dormitories. Pep rallies, class or team parades, etc., must be held in the gym or outside on the campus, under the supervision of the Physical Education faculty or the class sponsor. Breaking of this rule will be considered a serious offense.

IV. OFF CAMPUS.

The reputation of Virginia Intermont College is depen-

dent upon the conduct of Intermont girls. A student, while under the jurisdiction of the college, is expected to observe the social regulations of the college, whether she is on campus or registered out for week-ends. Student Government holds itself responsible for taking action in regard to the conduct of its members which endangers the reputation of the college.

A. 1. Seniors may go to town twice a week, one time being on Monday. Juniors and High School students may go on Monday. Merit credits may be used for additional trips to town. (See page 30.)

2. Girls are permitted to go to the Tenneva Bowling Alley on Monday afternoons.

3. These are the approved places in town for entertainment and eating:

B. Students may walk in afternoons from 4:00 p. m. until 5:15 p. m. as follows: Chester Street to Lee Heights, Euclid Avenue to Virginia High School, to Lawrence Street and back to Lee Heights; Moore Street to railroad.

C. On Sunday morning students will attend the church in Bristol for which they register in the office of the Dean of Women.

1. Two cuts from Sunday morning services are allowed each semester.

-
2. Two infirmary excuses cancel a cut from church.
 3. If a girl is excused from church while on campus, this Sunday must be made up.
 4. Four visiting cuts each semester to another church are permitted.
- D. 1. Students with "A" on deportment may accept an invitation of friends to take dinner with them once each quarter without chaperonage, such invitation subject to the approval of the Dean of Women. Additional invitations may be accepted by the use of Merit Credits. (See page 30.)
2. During the second semester, seniors in High School and College students may go to dinner and the movies in town on Saturday night chaperoned by a member of the Student Council. Each group will be limited to four girls plus the Council member, returning to the College by 9:45 p.m. The same privilege is permitted the first semester with faculty chaperonage.
- E. 1. Students may leave the college at six-week intervals on visits home or out-of-town, with permission sent directly from parent or guardian to the Dean of Women. Merit credits may be used for additional trips. Students returning from week-end trips must reach the college before eleven p.m. Infirmary excuses following week-end trips will be granted only in case of actual illness. Exceptions will be made for students living within a radius of fifty miles of Bristol who may go at four-week intervals.
2. Students are responsible to return from any week-end as agreed when signed out. Excuses will not be given for delays in travel. Overcuts from

classes affect Citizenship grades. These grades will determine many of the social privileges and eligibility for residence in Senior Hall. Citizenship will also be considered in determining eligibility for class and college offices.

F. Students will not be allowed to spend Easter or Christmas holidays in town.

G. Students returning to school after any holiday or absence must notify the Dean of Women of the time of arrival and they will be met and brought directly to the College. They will not be permitted to stay out in town.

H. DAILY REGISTER BOOK.

1. Each student, when leaving campus on Monday afternoons, shall sign out with her respective Assistant House President, and sign in on her return.
2. Each student, when leaving campus on all other days except Monday, is expected to sign out in the Daily Register Book on first floor Administration and to sign in on her return.
3. Reprimands are received for failure to sign in or out, and for mistakes in signing.
4. When signing out, please use 'S.P.' for senior privilege and write "special" for special permission; "M.C." for merit credits.

I. CHAPERONAGE.

Chaperone's are required only for safety, to protect students from being misjudged, and to safeguard the good name of Intermont students. It is assumed that everywhere students will act with sensitive regard to the standards of Intermont.

1. Students attending college dances at other colleges with permission from parents must be chaperoned by parent or someone approved by parent.
 2. Students attending out-of-town concerts, lectures, or dramatic productions must be chaperoned by members of the faculty.
 3. Students leaving the college in the evening must be chaperoned by members of the faculty and must return to the college by 10:15 p. m. Exception: See Section 4 under Dates.
 4. Students, when riding with young men, will be chaperoned by a member of the faculty. Exception: Students may go riding with approved friends, not local dates, on Sunday afternoons chaperoned either by a member of the Intermont Staff or officers of Executive Board of the Student Government Association.
 5. When a girl is chaperoned to the bus terminal or station she should pay the chaperone's fare back to the college.
- J. After college students and high school seniors have been enrolled at least one semester, they may go out unchaperoned with friends approved by parents and living outside a 50-mile radius of Bristol. Strict observation of all off-campus regulations is expected, and violation of this privilege will automatically remove it for the rest of the session.
- K. PERMISSIONS.
1. Any student may file a standing permission from her parents for over-night out-of-town visits from the college.
 2. Any student may file a standing permission from

her parents to attend out-of-town concerts, lectures, or dramatic productions.

3. Unless a student has a standing permission from parent or guardian, special permission must be filed for every out-of-town visit, and for each concert, lecture, or dramatic production.
4. A student shall telephone or telegraph the Dean of Women about any change of plans, intentional or otherwise, before the time her visit expires.
5. All telegrams are received and sent by the Dean of Women.
6. A student is not permitted to spend the night in town. Exception: A student, with permission of parents, may spend an occasional Sunday night in town with uncle or aunt.
7. Students may not spend the night at a hotel in town with parents or relatives of a roommate or suitemate. They may spend the night with their own parents or close relatives at the discretion of the parents.
8. No student may ride horseback until a written permission from parent or guardian has been filed in the Dean's office.
9. Students may spend Saturday night only in another girl's room in case the roommate is away. Permission slips must be secured before 1:00 p.m. each Saturday.
10. Virginia Intermont students do not attend movies on Sunday.

V. REPRIMANDS AND CAMPUS RULES.

- A. Reprimands are given for violation of dormitory

rules, such as visiting during evening study hour or after 10:30 p. m., etc. For ten reprimands, a call down before the Executive Council is given and also one week "strict campus." One week of "plain campus" is given for over-cut from class, chapel, vespers, church, or any entertainment at which attendance is required. "Strict campus" is given for breaking "plain campus" and other serious infraction of rules.

B. PLAIN CAMPUS RULES.

Students on "plain campus" are not permitted to leave the campus; to go to town; to visit either in or out of town; or receive young men callers; will not be allowed to take cuts from their church or to visit other churches on Sunday morning; must attend optional meals except breakfast.

C. STRICT CAMPUS RULES.

Students on "strict campus" must go to breakfast and must observe "plain campus." In addition, they will be deprived of the following privileges:

1. Going home except for holidays.
2. Taking cuts.
3. Leaving the campus with relatives, except with parents.
4. If a girl is late to any duty or receives a reprimand while on Strict campus, the Strict campus will be extended three (3) days.

D. CITIZENSHIP.

One half of the Citizenship grade for each quarter will be based upon conduct as shown in the Student

Council record by the adherence to general rules and regulations. The other half will be graded on the following five points, giving a maximum of ten to each point:

1. Co-operation and general attitude.
2. Care of person
3. Care of personal belongings and room.
4. Consideration for school properties.
5. Trustworthiness.

VI. MERIT SYSTEM.

- A. A system of merit credits is in vogue at Intermont by which students earn extra social privileges as a reward for good grades in class work. Merit Credits are counted as follows:

A in 5-hr. class	5 merit credits
A in 3-hr. class	3 merit credits
A in 2-hr. class	2 merit credits
A in 1-hr. class	1 merit credit
B in 5-hr. class	3 $\frac{1}{3}$ merit credits
B in 3-hr. class	2 merit credits
B in 2-hr. class	1 $\frac{1}{3}$ merit credits
B in 1-hr. class	2/3 merit credit
C in 5-hr. class	1 $\frac{2}{3}$ merit credits
C in 3-hr. class	1 merit credit
C in 2-hr. class	2/3 merit credit
C in 1-hr. class	1/3 merit credit

- B. A student who makes below "A" on deportment forfeits her merit credits.
- C. A student may secure the following privileges with merit credits:

- 1 extra trip to town may be secured with 1 merit credit.
- 1 invitation to luncheon on week-day in homes of friends in town may be secured with 1 merit credit.
- 1 extra date may be secured with 2 merit credits.
- 1 extra Sunday at home or out of town may be secured with 2 merit credits.
- 1 extra week-end home or out of town may be secured with 4 merit credits.
- 1 extra Sunday dinner with friends in town may be secured with 2 merit credits.
- 1 Monday luncheon in town for college seniors may be secured with 2 merit credits.
- 1 extra chapel cut per quarter may be secured by college students with 1 merit credit; by high school seniors, with 2 merit credits.
- 1 extra vesper cut per quarter may be secured by college students with 2 merit credits; by high school seniors, with 3 merit credits.
- 1 extra church cut per semester may be secured with 3 merit credits.

(Note: Cuts secured by merit credits must be recorded before they are taken, in the cut book.)

VIII. REGULATIONS FOR CUTS FROM CLASSES.

A. After first four weeks, cuts will be allowed as follows:

A in 5-hr. class	-----	3 cuts
B and C in 5-hr. class	-----	2 cuts
D in 5-hr. class	-----	1 cut
A and B in 3-hr. class	-----	2 cuts
C and D in 3-hr. class	-----	1 cut

- One cut is given for passing grade in 1 and 2-hr. classes.
- B. If excuses for absences are not handed to teachers within one week, the absences will be recorded by teachers as a cut.
 - C. Four lates cancel a cut.
 - D. For each over-cut from class one week's campus is given.
 - E. Excuses for illness are signed by the nurse; all others by the Dean of Women.
 - F. No cuts may be taken preceding or following holidays. (Note: The following will not be accepted as adequate excuses for absences: dental excuses, and excuses for general physical examinations.)
 - G. Seniors, college and high school, who made a good record the previous year, may take one of their cuts from each class after the first four weeks. Juniors and high school students, other than Seniors, are entitled to cuts on the basis of grades at the end of the first quarter. High school students must make a C in course to be cut; college student, D. No cuts are allowed on test days. If a student misses a test, she must pay one dollar to the accounts office and obtain a blue slip entitling her to take a special make-up test. Only in cases of excused absences will students be allowed to make up tests.

IX. FINANCIAL REPORTS FROM TREASURERS OF ORGANIZATIONS.

The Treasurers of the Y. W. C. A., Y. W. A., B. S. U., "The Intermont," and "The Cauldron" shall contact the business manager of the college for their sets of books,

shall keep the books in accordance with his instructions, furnishing the necessary reports and at the end of the year submitting their books for audit by the college accountant.

DRESS

For classes, almost any kind of tailored dress is appropriate—skirts and sweaters, woolen, cotton, linen, or silk dresses in season.

Socks or hose must be worn on the campus and for hiking on week days until 6:00 p. m. Socks are not worn in the dining room at dinner, when receiving callers, at social functions, nor on Sundays, except at breakfast. After April 1 girls may go stockingless except on Sunday.

For church and street wear suitable street dresses, shoes and hats are worn. Kerchiefs may be worn only on rainy days. Low-heeled shoes and socks may be worn to town.

For dinner, girls are expected to dress (informally) every evening. Heels are to be worn.

Special occasions. Formal evening clothes are worn for dances, and formal or semi-formal dresses are worn for teas, receptions, formal dinners, recitals, and concert numbers at the theater.

Blue Jeans may be worn on the back campus after classes in the afternoons, except on Sunday.

BANK OF INTERMONT REGULATIONS

1. ALL checks to be deposited or cashed must be made payable to the Bank of Intermont, to Cash, or to an individual and endorsed by that individual. No checks made out to Virginia Intermont College can be cashed.

2. Endorse all checks to be deposited or cashed.
3. Make out your own deposit slip before coming to the window. List and total all currency, silver and checks to be deposited.
4. Bank of Bristol checks are not negotiable and can be cashed only at the Bank of Intermont.
5. Make out all Bank of Bristol checks payable to CASH before coming to window.
6. You must present your passbook when making deposits or cashing Bank of Bristol checks. Be sure to check your passbook after each transaction. It is your responsibility to keep it correct.
7. Overdrafts and bad checks cannot be tolerated. If, through error, this type of transaction is made, it must be taken care of promptly. A fine of 10 cents per day will be assessed from date of notice.
8. Do not lose your passbook. You will be charged 25 cents for a new one. No money will be accepted for deposit and no withdrawals allowed unless you present your passbook.
9. A deposit of 50 cents is required for your room key. This deposit will be returned to you at the end of the year when you surrender your key. Please be careful not to lose your key. It is made of critical materials and perhaps we will not be able to replace it.

LIBRARY

Hours: The library is open every week day of the

college year from 8:30 a. m. to 1:00 p. m., from 2:00 to 5:00 p. m. and from 7:00 to 10:00 p. m., except on Monday afternoon and Saturday night.

Circulation: Books not reserved for classes may be borrowed for home use by teachers and students of the college. They may be taken out for two weeks and may be renewed for two weeks. Reference books and those reserved for classes are to be used in the library. The latter may be borrowed on Saturday at 4:00 for the week-end and during the week from 9:45 p. m. to 8:30 a. m. All books must be checked out at the desk before being taken from the library. Periodicals may be taken out for over-night and the week-end by teachers and officers only and must be checked out.

Fines: Books from the reserve shelf that are not returned on time are subject to a fine of fifteen cents for the first hour and five cents for each hour thereafter; other books not returned on time are subject to a fine of three cents for each day. Fines should be paid when the books are returned. If fines are not paid at the end of the quarter, grades will be withheld until they are paid.

Injury: Books lost or injured must be replaced or paid for. Ink is not used in the library except in fountain pens.

Order: A courteous demeanor, respect for books and furniture, and absolute quiet is expected of everyone.

STUDENT CHRISTIAN UNION

On September 8, 1942, the presidents and sponsors of the Y.W.C.A., Y.W.A., B.S.U., Student Government, and Senior Class met to formulate a plan to unify the work of the religious organizations on the campus. The name, "Student Christian Union", was adopted to include the three

religious organizations on occasions when all three are working together on one common project.

YOUNG WOMEN'S CHRISTIAN ASSOCIATION

The Y. W. C. A. is the oldest religious organization at Intermont College. Its purpose is found in the National Motto taken from John 10:10: "I am come that they might have life and that they might have it more abundantly," and the development of the "abundant life" is the ultimate purpose of all Y. W. C. A. activities.

The Social Committee begins to function on the first Saturday night when, in cooperation with the Y. W. A., a "Get Acquainted" party is held in the gymnasium, and throughout the year this committee plans a happy social life for its members. Then comes the annual Hallowe'en party to which young men in town are invited. The party comes just before Christmas Tea, one of the most delightful social functions of the year. During Exam. Week, the Y. W. C. A. is "At Home" to its members every afternoon from 4:00 to 5:30 in East Hall parlors, and the knowledge that one can drop in informally for a cup of tea by a cheery fire and relax after an examination does much to relieve the strain. Last, but not least, comes "Peanut Week", one of the most interesting social events sponsored by the Y. W. C. A. to foster good fellowship among the students.

On the first and third Tuesday of each month at 6:30, the regular Y.W.C.A. meetings are held in the chapel and to these all students are invited. Many of these meetings have become cherished traditions at Intermont, such as the first meeting of the year when "Everybody's Lonesome", the beautiful candle-light initiation service for new mem-

bers, the Christmas service, the splendid programs given by our neighboring students from King, Emory and Henry, and others. These meetings are always largely attended. Put these dates down on your schedule—Wednesday evenings from 6:30 to 7:00.

Through the "Interest Groups", congenial students may get together to enjoy their special hobbies, such as Travel, Art, Drama, Poetry, Music, Knitting, Photography, and any others they may wish.

All of the above activities are open to the members of the Y.W.C.A., and new students are cordially invited to join.

BAPTIST STUDENT UNION

The B. S. U. is the connecting link between the college and the local church, unifying all the voluntary religious activity of students on the local campus, and of Baptist students throughout the south.

B. S. U. offers to all students an attractive program of activity, including all the interests and organizations of the Boards and the promotional agencies of the denomination which affect student life.

B. S. U. promotes spiritual development and growth through sustained Bible study, prayer, mission study, and participation in the work of the church, of the denomination at large, and of other kingdom forces.

YOUNG WOMAN'S AUXILIARY

The Y.W.A. is the Young Woman's Auxiliary to the Woman's Missionary Society of the Southern Baptist Convention.

The purpose of the Y. W. A. is three-fold—first, to develop a symmetrical Christian young womanhood—second,

to bind together the young women of this college for world-wide service for Christ—third, to give instruction in the methods and mission work of her church.

Some of the beautiful ideals of the Y. W. A. are: Prayer and the study of God's word. Study of God's work in His world and the advancement of His Kingdom. A determination to give no offense in dress, personal appearance, speech or deportment, nor in any way shadow the purity and beauty of the Christ-like character.

The Y.W.A. holds its regular meetings at 6:30 on the second and fourth Tuesday of each month. In addition to these regular meetings, two special and very beautiful services are sponsored each year by the Y.W.A., the Christmas vesper service and the Palm Sunday program. One week in the year is set aside as Mission Study Week, and there are two special weeks of prayer observed for Home and Foreign Missions. This organization joins with the Y. W. C. A. in a variety of parties and other good times throughout the year, the first of which is the big "Welcome" party for the new girls on the first Saturday evening after the opening of school.

Any young woman in the college or on the faculty is eligible to membership in the Y. W. A.

"THE INTERMONT" AND "THE CAULDRON"

The Intermont student publications are THE CAULDRON, bi-weekly newspaper, and THE INTERMONT, the school year-book. The subscription price of both publications is included in the student activity fee paid by all boarding students.

The editor and business manager of THE CAULDRON are appointed by the faculty adviser, usually from the previous year's class in journalism. Other members of the

staff are chosen according to experience and ability, from journalism students and from the student body at large. THE INTERMONT is published by the Senior Class. The faculty sponsor, editor, and business manager are elected by the Senior Class each spring to serve the following year. The other staff members are chosen carefully from the entire student group at the beginning of the school year.

Any student in the college department is eligible for membership on the staff of either publication provided she has sufficient interest and ability.

ATHLETIC ASSOCIATION

Each girl who goes out for an after-school activity automatically becomes a member of the Athletic Association. During the year the Association sponsors practice and games in hockey, volleyball, basketball, and softball; tournaments in ping-pong, shuffleboard, badminton, tennis, and archery; and the annual song contest.

Excitement runs high during the weeks of class competition. A class emblem is given to each girl who plays on as many as two teams for her class.

Three weeks after the opening of school each new girl and faculty member is placed on a color team. There is a color team contest in each activity. The winner of a major contest wins 10 color team points, and the winner in a minor contest wins 5 color team points. The color team plaque is awarded at the final Athletic Association banquet.

There is an individual point system with a final award

of a club pin to the girls who gain 1,000 points. Each activity participated in adds points to your score.

The song contest is held in the fall. Each class presents two original songs and sings one of the songs from the preceding year's contest. The whole school turns out for a very interesting occasion and to select the winner of the Song Contest Plaque.

The Athletic Association is governed by a council made up of the following officers: president, vice-president, secretary, treasurer; a student head of each sport; a representative of each class; and representatives from the Boots and Saddle Club, the H₂O Club, and the Dance Club.

For a year of interesting activity and achievement, identify yourself with the Athletic Association the very first week of school.

MAY DAY ELECTIONS

- A. Nominations for the Queen shall be made by the entire student body at a called chapel meeting for this purpose. The number of nominees shall not exceed five and all classes are allowed to vote. Only Seniors at the time of nomination will be eligible for nomination to any office in the Court.

At the chapel meeting on week following these nominations, which are posted, there will be voting in chapel by the entire student body. The secret ballot will be used and votes will be counted by an appointed committee.

The runner-up for Queen shall automatically become Maid-of-Honor.

- B. Nominations for the Court, Trumpeters, and Crown Bearer will be made at the chapel following election

of Queen. The following number of nominees from each class will be represented:

High School may nominate not more than 5 Seniors.

Juniors may nominate not more than 8 Seniors.

Seniors may nominate not more than 10 Seniors.

The President of Student Government for the year is automatically the crowner of May Queen.

At the chapel meeting following the nominations meeting, there shall be voting in chapel by secret ballot in like manner as for the Queen.

Students who were nominated in the Queen section and were unsuccessful may be nominated the following week at the Court nominations.

The entire court, trumpeters, and crown bearer will be announced after the final voting.

PHI THETA KAPPA

The Grand Council of the Phi Theta Kappa has established a chapter in Virginia Intermont College. This is a junior college honor scholarship society corresponding to Phi Beta Kappa for four-year colleges. Chapters are established only in fully accredited junior colleges of the highest rank.

To be eligible for membership in Phi Theta Kappa, a girl must take at least twelve hours of liberal arts and make an average of 90% in her classes.

Qualifications for membership—a regularly enrolled student of satisfactory scholarship, who has participated in a major role of one long play or three one-act plays staged by Intermont Dramatic Department, who has done work of such high merit and quality as to be approved by the directors.

Initiation fee, \$1.50. Fraternity pin or ring from \$1.50 to \$25.00.
